# **Authority publishes book on its history**

After many challenging years and numerous hard-fought battles, the Georgia Superior Court Clerks' Cooperative Authority officially opened its doors on January 1, 1995. Today we celebrate 20 years of innovation, collaboration, and partnership with and service to Georgia's clerks of Superior Court and the citi-

zens of Georgia.

To honor and celebrate our 20<sup>th</sup> anniversary, we have published a book on our history entitled, For the Record: The Unique Success Story of the **GSCCCA**. The goal of the book is to permanently record the early battles, the ongoing development and implementation of myriad projects, and the ultimate success story of the Authority, and to memorialize the vision, inspiration and actions of individuals who worked tirelessly and collectively to achieve what many believed was not

possible.

The summary found on the book flap jacket says it best:

"The Georgia Superior Court Clerks' Cooperative Authority is arguably one of the most unique organizations in the country. While other states provide some of the same services, few agencies offer as many, as

efficiently, and at no cost to taxpayers.

"In the beginning, it was the vision and will of a handful of Superior Court clerks that convinced their colleagues across the state to sign on to a new way of doing things ... convincing them that they would not only become more efficient and better serve the citizens of Georgia, but they would retain control of their vital documents and maintain their revenue in the process. Later, it was a different

vision that guided the Authority's operations: the vision and commitment to contin-

### **April Board Meeting Review**

The Authority board met on April 15 for its quarterly meeting. Following is a summary of the reports and actions of the meeting.

#### **General Business**

The minutes of the January 14, 2015 scheduled board meeting were approved.

#### **Financial Review**

Greg Morgan, with Mauldin & Jenkins, reviewed the Authority's financial statements and reported that the Authority's financial health is good and there is cause for guarded optimism regarding the revenues for FY 2016. Jamie McCarron, GSCCCA financial director, presented the FY 2016 budget, and it was approved unanimously by the board as presented.



#### **Fines & Fees Division**

In an update on the Fines & Fees Division, it was reported that collections are down compared to FY 2014. There is an ongoing project to update contact information for all courts.

#### **Training Update**

It was reported that 42,500 registered users have registered for online training courses as of April 1, 2015. A UCC Online course has been added to the menu of courses for clerks of Superior Court and employees. Notary Public training for the public through clerks of Superior Court continues to be a success. Classes are scheduled throughout the state for sum-

mer and fall 2015. Fines & Fees training continues through ICJE.

#### eFile Project

An update was given on the Authority's eFile Project, and it was reported that 86 clerks' offices participate in UCC eFiling, 104 in Child Support, 18 in Real Estate eFiling, and 2 in Lien eFiling. A staff recommendation was made to modify the Real Estate Electronic Recording Standards for the State of Georgia, version 01/06/2015. The modification clarifies the process when multiple business entities, all issued Participant IDs, merge into one entity or one entity acquires the other. As recommended, a motion to adopt changes to the Real Estate Electronic Recording Standards for the State of Georgia, version 01/06/2015, was approved by the board.

#### **UCC Project**

As of March 2015, UCC filings across the state are down from the same time last year. If filings continue to be filed at the same pace for the last three months of FY 2015, the yearly total will be 9.5% less than FY 2014. Special recognition was given to the UCC Indexing Department for their dedication and good work.

#### **Notary Division**

It was reported that notary commissions for FY 2015 are down 7.1% compared to the same period for FY 2014. Apostilles are down 3.5%. A chart was presented showing apostilles issued for particular countries. Requests for Mexico lead all other countries.

#### **Historical Deed Re-Indexing Projects**

To date, 896,082 deed documents have been submitted in the Voluntary Historical Deed Project with 5,031 quarantined for review. For the Historical Deed Project, 17,843 documents have been submitted. Additionally, 63 docket surveys have been submitted.

#### **Premium Search Account**

It was reported that the total number of Premium Search accounts has increased from 2,468 to 2,571 (a 9.5% increase) since January 2015. This equates to revenues of \$64,567.50 per month.

#### **Microfilm Project**

It was reported that 19,630,000 images have been processed and shipped to the Georgia State Archives since the inception of the current microfilm process in January 2012. Care is taken to ensure that what is billed has actually been received by State Archives. Quality control checks are also conducted periodically to ensure that the quality of the microfilm meets required standards.

The citizens of Georgia have been saved thousands of dollars over the past three years due to the Authority's adoption of the current process.



#### **Book Presentation**

Chairman Wilkes proudly presented the Authority's recently published history, entitled *For the Record: The Unique Success Story of the GSCCCA*. The book details the creation of the Authority and subsequent years of existence. Board members, staff and vendors in attendance were presented a copy of the book.

### Authority's Fort honored by legislative group

Authority Ombudsman **Sharon Fort** was recently awarded the Georgia Women's Legislative Caucus Service Leadership Award. The GWLC is a bipartisan group founded in 1990 to support women in the Georgia General Assembly and to cultivate young aspiring profes-

sional women.

The award was given to 26 women across the state for their service to their respective communities, professional leadership, and service through policy, public service, and civic engagement to the citizens of Georgia.

ually improve current services and develop and offer new ones for the benefit of Superior Court clerks and the citizens of Georgia.

"From the game-changing 'first fax' in 1995 to the Authority of 2014, the organization has "And all would agree that the board's best asset was its unflappable director, the late David Williams, who joined the Authority early on and earned the respect of everyone who came into his circle.

"For the Record: The Unique Success Story of the GSCCCA tells all these stories and more. It's not just the history of a state agency. It's the story of a collective vision being realized through the selfless commitment of many. It's the story of innovation, collaboration and leadership. And in the end, it's the story of how government can and should work."

In a heartfelt and moving ceremony held on April 28 at the Clerks' Spring Conference on St. Simons Island, Chairman Barry Wilkes proudly presented the book to Georgia's clerks of Superior Court. In his presentation, he told the clerks about a conversation he had in the spring of 2013 with former executive director David Wil-

liams and their shared concern about clerks not knowing their history. As David said at the time: "Isn't it a shame that all clerks of Superior Court don't know the history of the Authority and all that we have faced to protect it from others since its creation." They agreed to remedy that problem and soon after commissioned this history to be written.

A Book Committee, which included Chairman Barry Wilkes, Vice Chairman Jean Rogers, board member Connie Cheatham and Authority consultant Gary Yates, was established to ensure the story was told accurately, and this group's guidance and contributions were critical to the success of the project.



Many special guests were on hand for the book ceremony including four inaugural board members: former Chairman Woodson Daniel, Joanne Caldwell, Sandra Glass, and Dan Jordan. Following the presentation, the Authority's current Board of Directors and members of the Authority staff posed with former members of the board.
